DIRECTIONS

To clean and deodorize or to pre-clean prior to disinfection, use 2 - 8oz of disinfectant per gallon of water depending on soil level.

<u>General cleaning</u>: Use in kitchens, bathrooms, restrooms, toilets and other areas. add ¼ cup (60mL) of Ultra Pine pe gallon of water. apply with a mop or sponge. discard solution when heavily soiled. No rinsing required.

<u>Laundry:</u> for heavily soiled areas and grease spots, rub in Ultra Pine full strength before washing. for extra deodorizing add $\frac{1}{2}$ cup (120mL) to water before adding to load. Use on whites and colour – fast garments only.

<u>Disinfecting</u>: Kills household germs on hard, non – porous surfaces such as surface and bathroom floors, toilets, diaper pails and pet areas. Apply Ultra Pine at full strength with a cloth or sponge. After 10 minutes, wipe away excess. for heavily soiled areas, clean excess dirt first.
