

# CARPET AND UPHOLSTERY SHAMPOO

#### DIRECTIONS

#### **Carpets**

Pre-clean desired surface with a vacuum or sweep area thoroughly. Dilute 1 part of shampoo in 10 parts of water. Be sure to agitate diluted solution before application. It can be applied with a mop, brush or applicator. Work solution into rug but do <u>not</u> soak- carpets should not be overly saturated. Allow carpet to dry for at least 4 hours or longer if necessary. Vacuum or sweep area when carpet has completely dried to remove loosened dirt and fluff nap.

#### <u>Upholstery</u>

Work diluted solution into fabric using a circular motion gradually moving from cleaned to dirty areas. Vacuum or brush thoroughly when dry. Do not use on velvet upholstery.

#### Spots/Stains

Use same dilution as above but apply only to affected areas. Clean spills up immediately since delay may cause the stain to set and hence lead to permanent damage.

NOTE: Some upholstery fabrics are not water washable. Test a small area/patch if in doubt before application.
